SECOND RENEWAL OF LICENSE AGREEMENT FOR PARKING LOT AT 6155-59 S. DAMEN, CHICAGO, ILLINOIS BETWEEN ONE IN CHRIST M.B.C., AS LICENSOR, AND THE BOARD OF EDUCATION OF THE CITY OF CHICAGO AS LICENSEE

THIS SECOND RENEWAL OF LICENSE AGREEMENT ("Second Renewal") is made as of this 1st day of July, 2015 (the "Effective Date") between One in Christ M.B.C. ("Licensor") and the Board of Education of the City of Chicago, a body politic and corporate ("Licensee").

RECITALS:

A. Licensor is the owner of the following property:

- B. The parties entered into a License Agreement ("License") on July 1, 2009 for a term from July 1, 2009 through June 30, 2014, for use of the Parking Lot by Licensee, for parking by Licensee's teachers, staff and patrons of Lindblom High School, at all times except: (i) Sundays from 8:00 a.m. to 3:00 p.m.; and (ii) at those certain times, to be determined and agreed to in writing, when Licensor holds special events ("Usage Times"). The parties renewed that License Agreement for a term commencing July 1, 2014 through June 30, 2015.
- C. The parties now desire to renew that License Agreement for a term commencing July 1, 2015 through October 31, 2015.

NOW, THEREFORE, in consideration of the foregoing Recitals, which are incorporated herein as though set forth in full, and for other good and valuable consideration in hand paid, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. <u>**DEFINED TERMS.**</u> Unless otherwise provided herein, all capitalized terms shall have the meaning set forth in the License.
- 2. <u>GRANT/RENEWALTERM.</u> Owner hereby licenses the Premises to Licensee, upon the terms and conditions hereinafter set forth, for an additional term of four (4) months commencing on July 1, 2015 and ending on October 31, 2015 (the "Second Renewal Term").
- 3. **TERMINATION FOR CONVENIENCE.** Licensee shall have the right to terminate the License for convenience by providing at least thirty (30) days prior written notice of such intent to terminate to the Licensor.
- 4. **RENT FOR RENEWAL TERM.** Rent for the Second Renewal Term shall be at the rate of \$3,500 per month for 4 months, payable on the first of each month, for a four month total of \$14,000.00.
- 5. <u>MAINTENANCE</u>. Licensee shall be responsible for snow removal and to clean and remove any and all debris from the Premises, at Licensee's sole cost and expense during the times of usage.

All notices shall be deemed to have been given when received, if hand delivered; when transmitted, if transmitted by facsimile or email; upon confirmation of delivery, if sent by recognized overnight courier; and upon receipt if mailed. Refusal to accept delivery has the same effect as receipt.

Licensor further acknowledges that this Agreement shall be posted on the Board's Internet website at www.cps.edu.
- 9. <u>COUNTERPARTS AND FACSIMILES</u>. This Second License Renewal may be executed in any number of counterparts, each of which shall be deemed to be an original, but all of which together shall constitute but one instrument.
