## FIRST AMENDMENT TO LICENSE AGREEMENT BETWEEN THE BOARD OF EDUCATION OF THE CITY OF CHICAGO AND CHRIST CENTER OF HOPE ASSEMBLY OF GOD Form 12/2013

This First amendment to License Agreement ("First Amendment") is entered into as of the 15<sup>th</sup> day of August, 2017 ("Effective Date") by and between the Board of Education of the City of Chicago, a body politic and corporate and commonly known as the Chicago Public Schools (the "Board" or "CPS" or "Licensor"), and Christ Center of Hope Assembly of God, a not-for-profit organization ("Licensee"), collectively (the "Parties").

#### RECITALS:

- A. The Parties entered into a License Agreement ("Agreement") for the use of certain Premises at Northside College Preparatory High School, 5501 N. Kedzie Ave, Chicago, Illinois for a term of no more than nine (9) years and 364 days commencing on the first Sunday following all necessary approvals relating to the Licensee's property from the Zoning Board. ("Term"); and
- B. The Parties hereto now desire to amend the Agreement as set forth below:

#### Premises

**NOW THEREFORE**, in consideration of the foregoing Recitals, which are incorporated into and made a part of this First Amendment and the mutual covenants contained herein, the Parties agree as follows:

1. **Defined Terms.** Any and all capitalized terms contained in this Amendment and not defined herein shall have the definition as set forth in the Agreement.

2. <u>Amended Provisions</u>. The following provision of the Agreement is amended as of the Effective Date of this First Amendment:

1. <u>Grant of License.</u> Licensor hereby grants to Licensee the non-exclusive right, privilege and permission, subject to the terms and provisions of this Agreement, to possess and occupy the following premises ("**Premises**"):

eight (8) spaces in the parking lot at 5430 North Kedzie Ave,

shall be amended to:

1. <u>Grant of License</u>. Licensor hereby grants to Licensee the non-exclusive right, privilege and permission, subject to the terms and provisions of this Agreement, to possess and occupy the following premises ("**Premises**"):

nine (9) spaces in the parking lot at 5430 North Kedzle Ave,

3. <u>Original Agreement</u>. Except as expressly provided in this First Amendment, all terms and conditions of the Agreement are and shall remain in full force and effect during the Term.
