(B) all right, title and interest of the Grantor, in and to all real estate, interest in lands, leaseholds, rights of ways, alleys, passages, tenements, hereditaments, privileges, easements, franchises, and appurtenances thereunto belonging or in any wise appertaining to the property;

subject to reverter to the CITY OF CHICAGO, IN TRUST FOR THE USE OF SCHOOLS, at such time as all principal, interest and premium, if any, on the Public Building Commission of Chicago Building Revenue Bonds, Series "A" of 1990, and all other administrative expenses of the Commission and all other accrued and unpaid expenses with respect to said revenue bond issue have been paid in full.
